I sincerely hope that you will continue to participate as Cando Members and look forward to your attendance at the 22<sup>nd</sup> Annual National Conference & AGM “*Investing in Aboriginal Economic Development*” that will be held on October 26-29, 2015 in Toronto, Ontario.

Cando has grown and matured as an organization, and has become more relevant to the needs of Economic Development Officers (EDOs) in Canada. This can be seen in the continuous growth in membership over the past year, and in the increasing numbers of EDOs enrolling in Cando’s Certified Aboriginal Economic Developer Process. Cando has evolved to better serve your needs and recognize the important contributions that you have made to Aboriginal economic development over the years.

The Cando Board attracts dedicated, strong-willed, committed and experienced EDOs who understand the benefits of volunteerism. Yukon’s Board member will need to have the skills and abilities to effectively deal with the challenges of building on and strengthening the governance regime adopted over the past years, and to ensure that Yukon’s concerns and the voice of EDOs continue to be reflected in the organization and its work. With this in mind, I am asking each and every **Full Cando member** in Yukon to give some serious consideration to representing your region on the Board for the next 3 years.

Included in this package are the Election Procedures that will be undertaken in Yukon, a Board Nomination form and a Membership Application form. The deadline to become a Cando member in order to be eligible to vote is **September 11, 2015. Please keep in mind that you must satisfy Cando’s “Full member” category to nominate or be nominated to the Board of Directors.**

## **CANDO YUKON BOARD of DIRECTOR**

Cando is a dynamic National Aboriginal community economic development organization dedicated to “*Building capacity to strengthen Aboriginal economies*”. The foundation of the organization is the Economic Development Officers (EDOs) who work through a host of Aboriginal communities and organizations across Canada. This is the profession that is dedicated to the challenge of fostering community and economic growth for Aboriginal people. Given that mandate, Cando is currently looking for an enthusiastic Economic Development Officer to represent Yukon on its National Board of Directors. This is a position elected by the region’s Economic Development Officers (**Full Cando members**) to ensure that Yukon has a voice and a presence in the organization.

### **Yukon Election Process**

Enclosed is a Cando membership application and nomination form.

Note: Only **Full Cando members** in the region can nominate and vote.  
**You have to be a Full member on or before September 11, 2015.**

#### **STEP 1 September 18, 2015 - Nominations for Yukon Director close.**

##### **Nomination Process:**

- Fill out nomination form
- Provide a biography no longer than 200 words
- Include a head & shoulder color photograph with the nomination
- Cando must receive the nomination form, bio, and photo via mail/courier/fax or e-mail on or before the close of business on **September 18, 2015**. *Cando will verify the nomination forms.*

**STEP 2 October 9, 2015 - Ballots issued.** All Yukon Full Cando members will be issued a ballot showing the Yukon Board of Director candidates.

**STEP 3 October 16, 2015 - Ballots closed.** All voting must be completed and faxed/e-mailed to Cando by the 4:30 pm (Mountain Standard Time) on **October 16, 2015**.

**STEP 4 Announcements** - Ballots will be tabulated on **October 19, 2015** and a notice of the election results will be made available on the Cando web site and in the next issue of the *Cando Connect Magazine*. All candidates will be notified of the results of the election. **The Board position will take effect on October 30, 2015.**

## **Cando Background**

Cando is a national non-profit organization that is Aboriginal-controlled, community-based and membership-driven. Cando's primary goal is to provide support to Economic Development Officers (EDOs) serving First Nations, Inuit and Métis. Cando is both a professional organization for EDOs and an advocate for the betterment of economic and social conditions for Aboriginal people.

## **Structure**

Cando is directed by a National Board consisting of elected representatives from:

Yukon	Quebec	Saskatchewan
Northwest Territories	Alberta	Manitoba
Atlantic (two)	Ontario	Nunavut
British Columbia (two)		
National Student Board Member (elected annually)		

Board positions are elected on a rotational basis for 3-year terms. The Board annually selects from amongst its members, the Executive Committee, consisting of a President, Vice-President and a Secretary-Treasurer. ***Board members are volunteers and receive no honoraria but are compensated for meeting expenses.***

## **Board Responsibilities**

The Board sets the overall direction of Cando and oversees its affairs. Board members are expected to assume standard responsibilities, which include financial affairs, corporate planning, membership, fundraising, and regional presentations. In addition, Board Members contribute to the development of new projects or services for Cando and its members. The Cando Board of Directors utilizes a number of *Standing* and *Ad Hoc* Committees to ensure a community-based and membership-driven approach to initiatives. It is expected that Directors will voluntarily sit on one or several Cando Committees. Therefore, a time commitment for a Director is required which should include: up to 2 in-person Board meetings per year, regular conference call meetings, committee meeting(s) and the Conference & Annual General Meeting attendance. All Cando Directors must sign the "*Cando Codes - Governing Directors*".

## **Board Eligibility**

To serve on the Cando Board you must be a Full Member of Cando and therefore employed with an Aboriginal organization or community and have the responsibility for community economic development. **You must be nominated by at least 1 (one) Full Cando member from your region and accept the nomination.**

## **Voting Eligibility**

To vote for a Cando Board nominee, **you must be a Full Cando member.**
